2	Additional Chief Administrator, Jalandhar Development Authority (JDA), Jalandhar	Revenue Districts of Jalandhar (excluding part of Phillaur Tehsil in GLADA at present), Kapurthala and Hoshiarpur

3	Additional Chief Administrator, Patiala Development Authority (PDA), Patiala	Revenue Districts of Fatehgarh Sahib and Patiala up to 2km south of NH 1, whole of Sangrur and Barnala district
4	Additional Chief Administrator, Greater Mohali Area Development Authority (GMADA), Mohali	Revenue Districts of Mohali and Ropar parts of Fatehgarh Sahib and Patiala District 2km beyond NH 1
5	Additional Chief Administrator, Greater Ludhiana Development Authority (GLADA), Ludhiana	Revenue Districts of Ludhiana, Moga Nawanshaher, part of Tehsil Phillaur of Jalandhar, District Ferozepur and Zira Tehsil of Ferozepur district
6	Additional Chief Administrator, Bathinda Development Authority (BDA), Bathinda	Revenue Districts of Bathinda, Mansa, Muktsar, Faridkot and Ferozepur (excluding the Tehsils of Ferozepur and Zira).
